BOARD OF SUPERVISOR'S MINUTE BOOK
CHEROKEE COUNTY, IOWA
JANUARY 2, 2007

The Cherokee County Board of Supervisors held their 2007 organizational meeting on Tuesday, January 2, 2007. The oath of office was given to elected officials by Magistrate Ryan Kolpin: Jeff Simonsen, Mark Leeds County Supervisors; Lynde Lundquist County Treasurer and Dawn Jones Coombs County Recorder. Mike Leckband of the *Chronicle Times* was also present.

County Auditor Bonnie Ebel opened the regular meeting and requested a motion for 2007 Board Chairman. MSP Schmidt, Graybill to appoint Ron Wetherell as 2007 Board of Supervisor Chairman. MSP Graybill, Schmidt to appoint Jeff Simonsen as Vice Chairman for 2007.

MSP Schmidt, Graybill to approve the amended agenda and minutes of the previous meeting.

Committee appointments were discussed and several changes were made. MSP Graybill, Simonsen to approve the committee appointments as discussed. Former Supervisors, Bud Clow will be asked to continue serving on the Solid Waste Commission as ad hock member. A full listing of committees can be seen in the Auditor's office.

MSP Graybill, Schmidt to appoint Jeff Simonsen to the Third Judicial District, Department of Correctional Services.

MSP Simonsen, Graybill to set regular Board of Supervisors meetings on Tuesday at 9:00a.m.

MSP Schmidt, Graybill to approve the appointment of Tom Jenness as County Weed Commissioner for the 2007 calendar year.

MSP Simonsen, Graybill to set the mileage rate for Cherokee County employees at 38 cents a mile.

MSP Simonsen, Graybill to name the Chronicle Times and Marcus News as official County newspapers.

Dick Sievers and Melissa Juhl from Mid Sioux Opportunities gave a report of activities that took place the last year. They are again requesting \$7,500.00 in funding with an extra \$1,500.00 for the Family Development and Self-sufficiency program in Cherokee County. These requests will be considered as budget work starts later this month.

Larry Clark, County Engineer brought one entrance permit. MSP Graybill, Simonsen to approve an entrance permit for Marvin Zoch in section 19 of Cherokee Township.

MSP Graybill, Leeds to appoint Jeff Lundquist as Trustee for Cedar Township and Jeff Kai as Trustee for Diamond Township.

MSP Simonsen, Leeds to accept the County Sheriff's quarterly report.

MSP Graybill, Simonsen to authorize the repair of the Crown Victoria not used by the Sheriff's office to be paid out of the Betterment Fund and title to the Aviation Authority to be used by the Airport as a visitor's car.

MSP Graybill, Simonsen to appoint Brenda Perrin to the Civil Service Commission as the Supervisors appointee.

Kris Glienke, Financial Manager, met to discuss setting a budget workday for all departments. Tuesday, January 23, 2007 will be a workday starting at 8:30 a.m.
