MSP Leeds, Schmidt to approve the amended agenda and minutes of the previous meeting.

MSP Graybill, Schmidt to approve the application for the Master Matrix for hog confinement construction for Open Range, Inc. in Section 19 of Marcus Township.

MSP Leeds, Schmidt to approve the application for the Master Matrix for hog confinement construction for D & J Pork in Section 19 of Liberty Township.

MSP Leeds, Schmidt to open the Public Hearing for the proposed 2008/2009 County Budget, roll call vote Schmidt aye, Graybill aye, Leeds aye, Wetherell aye, Simonsen aye.

MSP Graybill, Leeds to approve hiring Kady Brauning at \$12.00 per hour effective March 24, 2008 as Technology Coordinator/Auditor's Assistant. Wetherell voting nay.

Larry Clark, County Engineer discussed fencing issues with the snow being pushed off the roads. County Engineer will accept claims from citizens and turn them into County's insurance company for settlement.

MSP Graybill, Wetherell to approve the underground construction permit for Cherokee Rural Water for Section 21 of Sheridan Twp., Section 22 of Sheridan Twp., Section 34 of Tilden Twp., and Section 3 of Grand Meadow Twp.

MSP Graybill, Schmidt to approve Treasurer's office hiring Misty Daum at \$10.00 per hour effective March 10, 2008. Wetherell and Graybill voted nay.

MSP Graybill, Leeds to approve Chairman Simonsen sign the Grant application for the Veteran Affairs for the 2008 budget year. This is a \$10,000.00 matching State grant is already figured in the current fiscal year.
