BOARD OF SUPERVISOR'S MINUTE BOOK  
CHEROKEE COUNTY, IOWA  
FEBRUARY 23, 2010

The Cherokee County Board of Supervisors met in regular session on Tuesday, February 23, 2010 with Larry Prunty, Dean Schmidt, Jeff Simonsen, Mark Leeds, and Terry Graybill present. Mike Leckband, *Chronicle Times*, represented the press. Unless otherwise indicated, all votes were offered as follows: Ayes - Schmidt, Graybill, Prunty, Leeds, Simonsen; Nays – none; Abstentions – none.

Motion by Prunty, seconded by Schmidt to approve the agenda and minutes of the previous meeting. Motion carried.

Mark Buschkamp, CAEDC Director, gave an update of legislative bills concerning reorganization of the state mental health institutes. Buschkamp will organize a core group to represent Cherokee on a trip to the State Capitol.

Dave Shanahan and Marty Jenness, Engineer's Office, reviewed the 5 year construction plan and gave an update on snow removal.

Nancy Nelson, Deputy Assessor, and Kris Witcombe, Auditor's Assistant, presented the 2009 Family Farm Credits to disallow. Credits are disallowed on properties that have been sold or no longer qualify for the family farm status.

Motion by Leeds seconded by Graybill to disallow the 2009 Family Farm Credits as presented. Motion carried.

Motion by Schmidt, seconded by Prunty to approve a final payout of \$3,896.12 to Fred Claycamp for vacation and comp time. Motion carried.

Motion by Leeds, seconded by Graybill to approve a wage authorization for Joshua Douglas due to completion of a six month probation. Motion carried.

Motion by Leeds, seconded by Graybill to approve a contract amendment of the Local Multi-Hazard Mitigation Plan through SIMPCO. Motion carried.

Motion by Graybill, seconded by Leeds to ratify the tentative labor agreement with the Law Enforcement Center as signed by the union and county representatives on Wednesday, February 17, 2010. Motion carried.

Motion by Prunty, seconded by Schmidt to ratify the tentative labor agreement with the Secondary Roads Employees as signed by the union and county representatives on Wednesday, February 17, 2010. Motion carried.

There being no further business, Chairman Simonsen adjourned the meeting at 11:35 a.m.
