BOARD OF SUPERVISOR'S MINUTE BOOK
CHEROKEE COUNTY, IOWA
NOVEMBER 15, 2011

The Cherokee County Board of Supervisors met in regular session on Tuesday, November 15, 2011 with Larry Prunty, Dean Schmidt, Jeff Simonsen, Mark Leeds, and Terry Graybill present. Mike Leckband, *Chronicle Times*, and Terry Holub, *Aurelia Star*, represented the press. Unless otherwise indicated, all votes were offered as follows: Ayes - Schmidt, Graybill, Prunty, Leeds, Simonsen; Nays – none; Abstentions – none.

Motion by Prunty, seconded by Schmidt to approve the agenda and minutes of the previous meeting. Motion carried.

Motion by Prunty, seconded by Schmidt to open a public hearing to consider a development agreement with Sand Seed Service of Marcus. Roll call vote: Schmidt-aye, Graybill-aye, Prunty-aye, Leeds-aye, Simonsen-aye. Motion carried and public hearing opened at 9:00 a.m.

After hearing no comments from the public, a motion was made by Schmidt, seconded by Leeds to close the public hearing.

Motion by Leeds, seconded by Prunty to approve Resolution #2011-29 Approving a Development Agreement with Sand Seed Service to provide tax increment payments not to exceed \$415,750 for expansion of the current facilities. Roll call vote: Schmidt-aye, Graybill-aye, Prunty-aye, Leeds-aye, Simonsen-aye. Motion carried and resolution adopted.

Ginger Walker, Conservation Director, presented the Cherokee County Conservation Board's 2010/2011 Annual Report. Walker concluded by announcing her resignation from the Conservation Director position. The supervisors thanked Walker for her work on promoting Cherokee County through conservation projects and offered words of support as she starts her new position as a Farm Bill Biologist with Pheasants Forever.

Chairman Simonsen left the meeting at 10:30 a.m. to attend an Iowa State Association of Counties (ISAC) meeting in Coralville, Iowa. Vice Chairman Schmidt took over the proceedings.

Jeff Friedrichsen, Chief Deputy, and Rick Emswiler, Emswiler Architecture, presented drawings for a Law Enforcement Center (LEC) addition including redesign of the sidewalk and entrance to the current Sheriff's building. Leeds asked if a jail addition would require changes in the current jail to bring it up to current code. Friedrichsen answered that the current jail is fine and would not need updating. Emswiler indicated that he would verify that with the Iowa Department of Corrections and report back. Graybill asked if it would be a better option to consider housing prisoners in other counties and only using ours as a "holding tank". Friedrichsen added that it costs \$70 per day to house prisoners in other jails and the county would still need the same amount of staff.

Drainage from the courthouse property onto the LEC's parking and sidewalks was discussed. Schmidt stated that the county is waiting for written correspondence from the insurance carrier stating what corrective actions on the old alley would be acceptable. Kris Glienke, County Auditor, asked if there is a way to resurface the alley or design a wider sidewalk from the sheriff's office to the courthouse for use by deputies to escort prisoners for court appearances. Emswiler explained that because of the steep slope, there is not a way to design a safe sidewalk without several sets of steps and he suggested that the old alley be torn out and seeded to grass. Friedrichsen stated that a sidewalk or alley between the LEC and courthouse is not necessary because the deputies do not use it. Friedrichsen suggested a parking space reserved for law enforcement at the courthouse entrance to facilitate with transporting inmates to and from the court system. No action was taken and the subject will be discussed at a later date.

There being no further business, Vice Chairman Schmidt adjourned the meeting at 11:50 a.m. All board agendas and minutes are available online at www.cherokeecountyiowa.com.
