BOARD OF SUPERVISOR'S MINUTE BOOK
CHEROKEE COUNTY, IOWA
MARCH 29, 2016

The Cherokee County Board of Supervisors met in regular session on Tuesday, March 29, 2016 with Dennis Bush, Rick Mongan, Gary Lundquist, Jim Peck, and Jeff Simonsen present. Ken Ross, *Chronicle Times*, represented the press. Justin Pritts, Chad Brown, and Jeff Friedrichsen were also in attendance. Unless otherwise indicated, all votes were offered as follows: Ayes – Simonsen, Mongan, Lundquist, Peck, Bush; Nays – none; Abstentions – none.

Motion by Simonsen, seconded by Mongan to approve the agenda. Motion carried.

Motion by Peck, seconded by Lundquist to approve the minutes of the previous meeting. Motion carried.

Brandon Billings, Assistant Engineer, presented a right of way purchase agreement and construction contract for consideration.

Motion by Lundquist, seconded by Simonsen to approve a \$1,875.46 right of way permanent easement agreement with Jeannette Bruning for bridge replacement project #LFM-23--7X-18 on C66 in Silver Township. Motion carried.

Motion by Peck, seconded by Mongan to authorize the chairman to sign a contract with Christensen Bros. for bridge replacement project # LFM-23--7X-18. Motion carried.

Motion by Lundquist, seconded by Mongan to acknowledge a \$10.00 wage authorization for Tyler Smith, Seasonal Park Technician, as previously approved by the Cherokee County Conservation Board. Motion carried.

A request was received from the Cherokee Chamber of Commerce for use of two county roadways.

Motion by Simonsen, seconded by Mongan to approve a detour on Linden Street and S Avenue for the 50th Annual Cherokee Chamber PRCA Rodeo Parade on June 4, 2016. Motion carried.

Chairman Bush reported that the County Attorney is researching options for property owned by Cherokee County in Pilot Township. No action was taken.

Jeff Friedrichsen, Chief Deputy, gave an update on the final architect's review of the Law Enforcement Center Renovation Project and presented a quote from Century Link for moving poles in front of the building.

Motion by Peck, seconded by Mongan to authorize a \$9,719.85 payment to Century Link to move a utility pole as necessary to facilitate the Law Enforcement Center sidewalk project. Motion carried.

The supervisors provided committee reports and reviewed meeting schedules.

There being no further business, Chairman Bush adjourned the meeting at 9:40 a.m.
