The Cherokee County Board of Supervisors met in regular session on Tuesday, March 14, 2017 with Dennis Bush, Rick Mongan, Gary Lundquist, Duane Mummert, and Jeff Simonsen present. Motion by Simonsen, seconded by Bush to authorize the chairman to sign a contractor's performance bond and contract with Mathy Construction for the L-51 overlay project. Motion carried.

Motion by Mummert, seconded by Lundquist to acknowledge an \$18.50 wage authorization for Blake Jesse, Conservation Tech, as previously approved by the Cherokee County Conservation Board. Motion carried.

County held tax certificates were discussed. Further discussion and possible action was tabled for additional research.

Chairman Mongan reported that proposed union contracts have been ratified by local members and signed by Operating Engineers Local 234 representatives.

Motion by Simonsen, seconded by Bush to approve a one year contract with the Law Enforcement Center union employees. Motion carried.

Motion by Mummert, seconded by Lundquist to approve a one year contract with the Secondary Roads union employees. Motion carried.

The supervisors provided committee reports and reviewed meeting schedules.

There being no further business, Chairman Mongan adjourned the meeting at 10:05 a.m.
