Brandon Billings, County Engineer, presented a letter from an entity requesting permission to use county right of way and utility permits for consideration.

Motion by Simonsen, seconded by Bush to approve an underground utility permit for Cherokee Rural Water in Section 7 of Marcus Township. Motion carried.

Motion by Bush, seconded by Lundquist to approve an overhead utility permit for Mid American Energy in Section 16 of Rock Township. Motion carried.

Motion by Simonsen, seconded by Bush to authorize the chairman to sign a request from the Powder Players, Inc. Snowmobile Club to maintain a trail system in Marcus Township. Motion carried.

Jerod Clyde, County Sheriff, presented a wage authorization for consideration.

Motion by Mummert, seconded by Simonsen to approve a \$20.28 wage authorization and change of position for Keva Wolf, from Jailer to Jail Administrator, effective October 24, 2017. Motion carried with Lundquist voting nay.

Motion by Bush, seconded by Simonsen to approve property tax suspensions per DHS guidelines under Iowa Code 427.9 for the following parcel: 98-07-23-352-014. Motion carried.

The supervisors provided committee reports and reviewed meeting schedules.

There being no further business, Chairman Mongan adjourned the meeting at 10:17 a.m.
