The Cherokee County Board of Supervisors met in regular session on Tuesday, June 12, 2018 with Dennis Bush, Rick Mongan, Gary Lundquist, Duane Mummert, and Jeff Simonsen present. Motion by Mummert, seconded by Lundquist to authorize the chairman to sign a DNR confinement application and Master Matrix scoring sheet for T & M Cattle (Chad Tentinger) in Section 19 of Amherst Township. Motion carried.

The supervisors provided committee reports and reviewed meeting schedules.

There being no further business, Chairman Mongan adjourned the meeting at 10:02 a.m.
