

ORDINANCE NUMBER 2005 –01

An Ordinance establishing election precincts for Cherokee County, Iowa

Section 1. Purpose: The purpose of this ordinance is to establish election precincts for Cherokee County, merging previous precincts to reduce the cost of elections.

Section 2. In accordance with sections 49.8 of the CODE OF IOWA the election precincts shall be:

Section 3. General Provisions:

- 1. Combination of existing precincts. To carry out the purpose of this ordinance, existing precincts in Cherokee County shall be combined as follows:**
 - a. Afton Precinct; all of Afton Township, all of Diamond Township, All of Pitcher Township includes the city of Aurelia and all of Spring Township shall be combined to form Afton/Diamond/Pitcher/Spring Twp. Precinct.**
 - b. Marcus Precinct; all of Marcus Township includes the city of Marcus, all of Liberty Township, all of Amherst Township and all of Sheridan Township includes the Cities of Meriden and Cleghorn shall be combined to form Marcus/Amherst/Liberty/Sheridan Twp. Precinct**
 - c. Pilot Precinct; all of Pilot Township, all of Cedar Township includes the City of Larrabee, all of Cherokee Township shall be Pilot/Cedar/Cherokee Twp. Precinct**
 - d. Willow Precinct; all of Willow Township, includes cities of Quimby and Washta, all of Grand Meadow Township, all of Rock Township, all of Tilden Township all of Silver Township, shall be Willow/Grand Meadow/Rock/Tilden/Silver Twp. Precinct.**
- 2. Remaining existing Precincts of City of Cherokee, Cherokee City Ward #1, Cherokee City Ward #2 and Cherokee City Ward #3 shall remain as currently designated.**
