BOARD OF SUPERVISOR'S MINUTE BOOK
CHEROKEE COUNTY, IOWA
JULY 14, 2009

The Cherokee County Board of Supervisors met in regular session on Tuesday, July 14, 2009, with Larry Prunty, Dean Schmidt, Terry Graybill, Jeff Simonsen, and Mark Leeds present. Mike Leckband, *Chronicle Times*, represented the press. Unless otherwise indicated, all votes were offered as follows: Ayes – Schmidt, Graybill, Prunty, Leeds, Simonsen; Nays – none; Abstentions – none.

Motion by Leeds, seconded by Prunty to approve the amended agenda and minutes of the previous meeting. Motion carried.

Dave Scott, Sheriff, and Jeff Friedrichsen, Chief Deputy, reviewed their June 30th quarterly revenue report.

Motion by Graybill, seconded by Schmidt to approve the Sheriff's June 30th quarterly revenue report as presented. Motion carried.

Dave Skou, 911 Director, requested authorization to fill a Chief Dispatcher position to assist with administrative duties in the Communications Center. Dispatcher and jailer positions were discussed at length.

Motion by Graybill, seconded by Schmidt to approve a full time jailer/dispatcher position for Alisha Droegmiller. Motion carried.

Motion offered by Simonsen to approve a wage authorization for Stacy McGee to fill the supervisor position of Chief Dispatcher. Motion died due to the lack of a second.

Richard Wych visited with the supervisors about the duties of the Veteran Affairs Commissioners. Appointment of a VA Commissioner was tabled.

Dawn Jones Coombs, County Recorder, reviewed her June 30 quarterly revenue report and annual revenue summary.

Motion by Graybill, seconded by Prunty to approve the Recorder's June 30th quarterly revenue report as presented. Motion carried.

Hedgie Brandt, Treasurer, presented a delinquent tax parcel that two citizens have requested to purchase for less than the total amount of taxes due. The consensus of the supervisors was to maintain sale of delinquent property at the actual amount of taxes due and not to discount the property taxes due.

Dave Shanahan, County Engineer, discussed state regulations for bridge inspections.

Motion by Graybill, seconded by Leeds to approve the claims for payment as presented. Motion carried. A complete listing is available for review in the Auditor's office and online.

There being no further business, Chairman Simonsen adjourned the meeting at 11:30 a.m.
