The Cherokee County Board of Supervisors met in regular session on Tuesday, November 12, 2013 with Mark Leeds, Dennis Bush, Rick Mongan, Jeff Simonsen, and Ginger Walker present. Dan Whitney, *Chronicle Times*, represented the press. Lindsay Bressler and Rick Angell were also in attendance. Unless otherwise indicated, all votes were offered as follows: Ayes – Simonsen, Mongan, Bush, Walker, Leeds; Nayes – none; Abstentions – none.

Motion by Mongan, seconded by Simonsen to approve an amended agenda to include a wage authorization for a new Sheriff's hire. Motion carried.

Motion by Simonsen, seconded by Walker to approve the minutes of the previous meeting. Motion carried.

Marlene Ebert, Jail Administrator, presented a wage authorization for consideration.

Motion by Simonsen, seconded by Walker to approve a \$14.91 per hour wage authorization for ReAnn Jackson, part-time Jailer, per the Law Enforcement Center Union Contract with a November 13, 2013 effective date. Motion carried.

Rick Angell, Wellmark Blue Cross/Blue Shield of Iowa Representative, provided information of additional health insurance fees that will begin with the County's December 2013 billing as a result of the Affordable Care Act (ACA). The consensus of the board was to notify employees that they individually should be prepared to assume the monthly health insurance fees assessed on each employee and covered family member. It is anticipated that the premium adjustment fees will be handled through payroll deductions beginning in December 2013 for January 2014 health coverage. Informational employee meetings are scheduled with representatives from Wellmark and Three Rivers Benefit Corporation in attendance to answer questions and facilitate the County's annual Cafeteria Plan enrollment process.

Jill Titcomb, Auditor's Election Assistant, reviewed the November 5, 2013 City Election results. Motion by Simonsen, seconded by Bush to certify the Canvass of 2013 City Election results.
