BOARD OF SUPERVISOR'S MINUTE BOOK  
CHEROKEE COUNTY, IOWA  
AUGUST 29, 2017

The Cherokee County Board of Supervisors met in regular session on Tuesday, August 29, 2017 with Dennis Bush, Rick Mongan, Gary Lundquist, Duane Mummert, and Jeff Simonsen present. Ken Ross, *Chronicle Times*, and Steve Peterson, *Aurelia Star*, represented the press. Dana Evans and Gerald Weiland were also in attendance. Unless otherwise indicated, all votes were offered as follows: Ayes – Simonsen, Bush, Lundquist, Mummert, Mongan; Nays – none; Abstentions – none.

Motion by Bush, seconded by Lundquist to approve the agenda. Motion carried.

Motion by Mummert, seconded by Simonsen to approve the minutes of the previous meeting. Motion carried.

Brandon Billings, County Engineer, presented a utility permit for consideration.

Motion by Lundquist, seconded by Simonsen to approve an underground utility permit for CML Telephone in Section 4 of Cherokee Township. Motion carried.

Motion by Mummert, seconded by Bush to authorize the chairman to sign a DNR confinement application and Master Matrix scoring sheet for Mike Radke in Section 12 of Diamond Township. Motion carried.

Mongan reported that Rick Emswiler, Emswiler Architecture, was disappointed that the supervisors did not accept his offer to pay for half of the additional expenses associated with correcting an ADA ramp at the Law Enforcement Center. Emswiler stated that he had never used his liability insurance during his years of owning his architect business, but he would file a claim and report back to Cherokee County.

Motion by Simonsen, seconded by Lundquist to approve a separation of employment and \$810.00 final payout of hours worked for Adam Cedar, Secondary Roads Temporary Laborer, effective August 15, 2017. Motion carried.

Motion by Simonsen, seconded by Bush to approve a separation of employment and \$616.00 final payout of hours worked for Carre Stevenson, Conservation Seasonal Tech, effective August 16, 2017. Motion carried.

Motion by Mummert, seconded by Lundquist to approve a separation of employment and \$343.68 final payout of hours worked for Erin Sonksen, EMS/EH Assistant, effective August 23, 2017. Motion carried.

The supervisors provided committee reports and reviewed meeting schedules.

There being no further business, Chairman Mongan adjourned the meeting at 9:40 a.m.
