Motion by Simonsen, seconded by Lundquist to authorize the Chairman to sign the Five-Year Construction Program previously approved on March 20, 2018. Motion carried.

Motion by Simonsen, seconded by Mummert to approve a separation of employment and \$746.67 final payout of vacation for William Robinson, Part Time Dispatcher, effective March 17, 2018. Motion carried.

Greg Zarr, County Assessor and Brian Leinen, Vanguard Appraisals, provided information on the 2018 Revaluations. Property owners who are not satisfied with their 2018 revaluations, may meet with the County Assessor for an informal appeal process April 2 through April 25 and/or may file an appeal application with the Assessor's Board of Review. Those applications will be accepted April 2 through April 30.

The supervisors provided committee reports and reviewed meeting schedules.
